## **1. Welcome and Opening Remarks**

- President Deb Zelez welcomed all and thanked everyone for attending.

## **2. Approve 2016-2017 Meeting Minutes**

- The first order of business was to accept the minutes from the previous year's AGM. Berry Urban motioned to accept the minutes from the AGM on October 27, 2016 and Jan Langley seconded. The motion was carried.

## **3. Registrars Report**

- Emma is hoping for some more interest and attendance in upcoming Masters Swim Meets. The next meet is in Calgary.
- The swim clocks have been replaced by the manufacturer as they were unable to fix our old clocks. They are now at the pool and ready for use.

- Deb asked if anyone had any other business they would like to address. No one in attendance had any other business they wanted to discuss.

#### **7. Elections**

- Deb Zelez, president of the OMSC Board advised that elections were necessary as both herself and MJ Meyers (Vice President) had completed their terms, and are standing down.
- Chris Hider started the election by letting us all know that 1 nomination for president had been received. The nomination for Breanne Leach as president was received via email by Amber Arnold. Jan Langley seconded this nomination. Chris Hider asked if Breanne would accept the nomination. Breanne Leach accepted. Breanne Leach is the new President of the Okotoks Masters Swim Club.
- Chris Hider stated the next position up for nomination is Vice President. Chris Hider asked for any nominations. Breanne Leach nominated Berry Urban. MJ Meyers seconded this nomination. Chris Hider asked if there were any additional nominations. No other nominations were presented. Chris Hider asked Berry Urban if she accepted the position of Vice President. Berry Urban accepted. By acclamation Berry Urban is the new Vice President of the Okotoks Masters Swim Club.
